### BY-LAW #18/09

#### **OF THE**

### **RURAL MUNICIPALITY OF ROCKWOOD**

Being a By-Law of the Rural Municipality of Rockwood to regulate activities at the Balmoral & Winfield Road Waste Transfer Stations.

**WHEREAS** Sections 232(1) (b) of The Municipal Act, S.M. 1996, C. M225, provides, in part:

- "232(1) A council may pass by-laws for municipal purposes respecting the following matters:
- b) people, activities and things in, on or near a public place or a place open to the public, ...";

**AND WHEREAS** Sections 232(2)(a) and (d) of The Municipal Act, S.M. 1996, C. M225, provides, in part:

- "232(2) Without limiting the generality of subsection (1), a council may in a by-law passed under this Division
- a) regulate or prohibit; ... and
- d) establish fees or other charges for services, activities or things provided or done by the municipality or for the use of property under the ownership, direction, management or control of the Municipality";

**AND WHEREAS** it is deemed expedient and in the best interest of the Municipality to pass a By-Law to regulate activities at the Balmoral & Winfield Road Waste Transfer Stations to plan, organize, control and supervise the transportation, treatment, handling, disposal, prevention, reduction, reuse or recycling of waste and the recovery of materials, substances or energy from waste through the operation of the Balmoral and Winfield Road Transfer Stations;

**NOW THEREFORE** the Council of the Rural Municipality of Rockwood, in Council duly assembled, enacts as follows:

#### 1. **DEFINITIONS:**

Where used herein, the following words shall have the following meaning:

- a) "<u>Balmoral Waste Transfer Station</u>" shall mean the Balmoral Waste Transfer Station located at Pt. NE 5-15-2E, 7099 Road 85N (PR 236) and is owned and operated by the Rural Municipality of Rockwood.
- b) "<u>Person</u>" shall mean any individual and includes a corporation, firm, partnership, institution and association.
- c) "<u>Winfield Road Waste Transfer Station</u>" shall mean the Winfield Road Waste Transfer Station located at Pt. NE 19-13-2E, Winfield Road 6091E, Road 76N and is owned and operated by the Rural Municipality of Rockwood.

## 2. **SUPPLEMENTARY MUNICIPAL FUNDING:**

The cost of operating the Waste Transfer Stations are to be covered by the fees and levies collected for the disposal of wastes from all users, including the Rural Municipality of Rockwood. If, in a fiscal year, the amount of the fees and levies collected is insufficient to cover the operating costs of the Waste Transfer Stations, the deficits shall be recovered by the Rural Municipality of Rockwood.

### 3. **CLASSES OF WASTE:**

The following shall define, for the purposes of this By-Law, the classes of waste that may or may not be disposed of at the Waste Transfer Stations:

- a) "<u>Agricultural Waste</u>" shall mean excess materials derived from agricultural activities and, without limiting the generality of the foregoing, shall include, but is not limited to, crop residues, herbicides, pesticides, fertilizers, and like materials from all agricultural pursuits.
- b) "<u>Animal Waste</u>" shall mean manure, excrement, animal carcasses, or any parts or mixtures thereof.
- c) "Ashes" shall mean the cold residue resulting from the burning of a substance.
- d) "<u>Combustible Waste</u>" shall mean, but is not limited to, tree boughs, stumps and branches, paper and cardboard products, wood and lumber and packaging materials derived from paper, cardboard and wood.
- e) "Construction/Demolition Waste" shall mean a mixture of waste building materials and rubble resulting from construction, remodelling, renovations, repairs, demolition or fire in buildings and other structures and includes, but is not limited to, lumber, plaster, concrete, drywall, glass, shingles, siding, electrical, and plumbing fixtures and piping or any combination thereof. Construction/Demolition Waste may be reclassified as Ashes, Combustible, Excavation, Metallic or Recyclable wastes provided said Construction/Demolition Waste is separated as per the Classifications defined in this Section.
- f) "Excavation Waste" shall mean natural soil, earth, sand, gravel, asphalt, concrete and stone or any parts or mixtures thereof.
- g) "<u>Hazardous Waste</u>" shall mean a substance that is designated a hazardous waste by regulation under The Dangerous Goods Handling and Transportation Act.
- h) "Industrial Waste" shall mean solid and liquid waste materials resulting from, or incidental to, the manufacture, processing, or like operation of factories, processing plants, industrial processes and manufacturing operations and includes waste such as putrescible waste from food processing plants and rendering plants and condemned foods and products.
- i) "Landfill Waste" shall mean all discarded waste but does not include Agricultural Waste, Animal Waste, Ashes, Combustible Waste, Construction/Demolition Waste, Excavation Waste, Hazardous Waste, Industrial Waste, Liquid Waste, Metallic Waste, Recyclable Waste, and Yard Waste.
- j) "<u>Liquid Waste</u>" shall mean sewage, sewage effluent, and sludge from septic tanks, holding tanks, and municipal sewage treatment systems.
- k) "<u>Metallic Waste</u>" shall mean, but is not limited to, derelict vehicles, farm machinery, appliances, and any other items, goods or things that are comprised entirely or mostly of some type of a metal substance or substances.
- 1) "Ozone Depleting Substance" shall mean substances as regulated under The Ozone Depletion Substances Act.
- m) "Recyclable Waste" shall mean those wastes as listed in Schedule "B" to this By-Law, as may be amended by the Board from time to time.
- n) "<u>Waste Oil</u>" shall mean oil, lubricants, grease, petroleum and like substances.

- o) "Waste Tire" shall mean tires discarded for reasons of wear or damage.
- p) "Yard Waste" shall mean leaves, grass clippings, garden and flower bed vegetation and straw.

### 4. **REGULATIONS:**

All persons disposing of waste at the Balmoral Waste Transfer Station or the Winfield Road Waste Transfer Station shall do so in accordance with this By-Law and regulations contained herein or as established by Council from time to time.

- a) No person shall set or ignite any fire in the Waste Transfer Stations.
- b) No person shall dispose of the following Classes of Waste at Waste Transfer Stations:
  - i) Agricultural Waste
  - ii) Animal Waste
  - iii) Construction/Demolition Waste
  - iv) Industrial Waste
  - v) Hazardous Waste
  - vi) Liquid Waste
  - vii) An Ozone Depleting Substance which has not been rendered safe as per the Ozone Depletion Substances Act
  - viii) Waste Oil
- c) The following Classes of Waste may be disposed of at the Waste Transfer Stations:
  - i) Ashes, provided said ashes are cold
  - ii) Combustible Waste
  - iii) Excavation Waste, not including concrete rubble
  - iv) Landfill Waste
  - v) Metallic Waste
  - vi) Ozone Depleting Substance, provided the substance has been rendered safe as per The Ozone Depletion Substances Act
  - vii) Recyclable Waste
  - viii) Waste Tires
  - ix) Yard Waste
- d) All persons who attend the Waste Transfer Stations to dispose of waste shall separate their waste as per the Classes of Waste permitted for disposal at the Waste Transfer Stations.
- e) All persons who attend either Waste Transfer Station shall report to the Caretaker's Office and shall pay the applicable fee.
- f) All persons who attend either Waste Transfer Station to dispose of waste shall dispose of allowable waste in such designated area or bins, as the case may be, and in such a manner as directed by the Waste Transfer Station Personnel.
- g) No person shall at any time deposit or dump any waste outside of the fence of the Waste Transfer Station but shall only dispose of waste in those areas or bins, as the case may be, as designated by the Waste Transfer Station Personnel.
- h) It is unlawful for any person to salvage, pick over, scatter, search, or burn any waste in the Waste Transfer Stations unless said person has received prior written authorization from Council.

i) No person shall loiter in the said Waste Transfer Stations, but rather they shall simply attend a Waste Transfer Station for the purpose of disposing of allowable waste and thereafter they shall immediately leave the Waste Transfer Station.

### 5. **FEES:**

All persons who attend either Waste Transfer Station shall pay, at the time of attendance, the applicable fee for the disposal of the allowable waste as per the Class of Waste and the Fees as set out in Schedule "A" attached hereto and forming a part of this By-Law and as amended from time to time.

## 6. **PENALTIES:**

- a) Any person who contravenes or refuses, neglects, omits, or fails to obey or observe any provision of this By-Law is guilty of an offence and liable, upon summary conviction, in addition to costs, to a fine not exceeding FIVE HUNDRED DOLLARS (\$500.00) or to imprisonment for a term not exceeding one (1) month, or both such fine and imprisonment.
- b) Where the contravention, refusal, neglect, omission, or failure, including failure to comply with a notice, order or direction give by the Board, continues for more than one occurrence, the person is guilty of a separate offence for each occurrence.

### 7. **SEVERABILITY:**

If any provision of this By-Law is held to be invalid by any Court of competent jurisdiction, the remaining provisions of this By-Law shall not be invalidated.

## 8. **EFFECT:**

This By-Law, #18/09, shall come into force and effect on and from the 1<sup>st</sup> day of October, 2009.

9. That By-Law #22/08 is hereby repealed.

## SECTION II: ADDITIONAL FEES

Any person who contravenes or disobeys, or refuses or neglects to obey Section 4. d), e), f), or g) of the Regulations provision of By-Law #18/09 may be liable to a fee of \$100.00 for each contravention, refusal, neglect, omission, or failure, and such fee is in addition to the fee as setforth in Section I of Schedule "A" above.

### **SECTION III: EXEMPTIONS**

Disposal fees shall not be charged to the Waste Collection Contractor for disposal in the Balmoral Waste Transfer Station when he is disposing of waste collections from the Townsites of Argyle, Balmoral and Gunton on Thursdays of each week.

(Note: The Waste Collection Contractor shall not dispose of any waste collections at the Winfield Road Waste Transfer Station.)

# **RECYCLABLE WASTE:**

The following items are classified as recyclable waste:

Tin Cans

Glass Bottles and Jars

All Aluminum Cans

All types of soft drink containers (aluminum, glass, and plastic)

All liquor, wine, and beer bottles and cans

Milk Cartons

Newspapers (NO GLOSSY FLYERS)

All Plastic Containers with a #2 symbol on the bottom

All recyclable waste **must** be clean and dry
