## **BY-LAW #11/14**

# **OF THE**

# RURAL MUNICIPALITY OF ROCKWOOD

Being a By-Law of the Rural Municipality of Rockwood to set Reduced-Speed School Zone within the Rural Municipality of Rockwood.

WHEREAS Section 98(1) of The Highway Traffic Act and The Reduced-Speed School Zones Regulation No. 136/2013 authorize a council to pass by-laws establishing the reduced maximum permitted speed for vehicles being driven on a highway within a school zone with the geographic boundaries of a municipality; and

AND WHEREAS the Council of the Rural Municipality of Rockwood deems it advisable and in the best interested of the Municipality to establish school zones with a reduced maximum speed for vehicles;

NOW THEREFORE the Council of the Rural Municipality of Rockwood, in Council duly assembled, enacts as follows:

### 1. **INTERPRETATION:**

For the purposes of this By-Law, "highway', "reduced-speed school zone", 1.1 "school", "school property", "traffic control device", and "vehicle" have the same meaning as set out in The Highway Traffic Act and The Reduced-Speed School Zones Regulation No. 136/2013.

### **ESTABLISHMENT OF REDUCED-SPEED SCHOOL ZONES:** 2.

That the reduced speed limit for motor vehicles as identified below, pertain to the 2.1 travelled portion of highway within 150 meters along the highway in either direction beyond the limits of the land used for the purpose of the school as a school zone during times as specified:

### 3. **TRAFFIC CONTROL DEVICES:**

- 3.1 The Municipality shall identify a Reduced-Speed School Zone with traffic control devices that comply with The Reduced-Speed School Zones Regulation No. 136/2013.
- That By-Law #10/14 is hereby and is repealed upon Third Reading of this By-Law, #11/14. 4.
