OF THE

RURAL MUNICIPALITY OF ROCKWOOD

Being a By-Law of the Rural Municipality of Rockwood to regulate activities at the Teulon-Rockwood Waste Disposal Grounds.

WHEREAS Sections 232(1) (b) of The Municipal Act, S.M. 1996, C. M225, provides, in part:

"232(1) A council may pass by-laws for municipal purposes respecting the following matters:

b) people, activities and things in, on or near a public place or a place open to the public, ...";

AND WHEREAS Sections 232(2)(a) and (d) of The Municipal Act, S.M. 1996, C. M225, provides, in part:

"232(2) Without limiting the generality of subsection (1), a council may in a by-law passed under this Division

- a) regulate or prohibit; ... and
- d) establish fees or other charges for services, activities or things provided or done by the municipality or for the use of property under the ownership, direction, management or control of the Municipality";

AND WHEREAS it is deemed expedient and in the best interest of the Rural Municipality of Rockwood to pass a By-Law to regulate activities at the Teulon-Rockwood Waste Disposal Grounds and to plan, organize, control and supervise the transportation, treatment, handling, disposal, prevention, reduction, reuse or recycling of waste and the recovery of materials, substances or energy from waste through the operation of the Teulon-Rockwood Waste Disposal Grounds;

NOW THEREFORE the Council of the Rural Municipality of Rockwood, in Council duly assembled, enacts as follows:

1. **DEFINITIONS:**

Where used herein, the following words shall have the following meaning:

- a) "<u>Teulon-Rockwood Waste Disposal Grounds</u>" shall mean the Teulon-Rockwood Waste Disposal Grounds located at Pt. SW 30-16-2E, 6066 E, Road 94N, located in the Rural Municipality of Rockwood, jointly owned by the Town of Teulon and the Rural Municipality of Rockwood.
- b) "<u>Non-resident</u>" shall mean any individual who does not reside in nor owns real property either in the Rural Municipality of Rockwood or the Town of Teulon
- c) "<u>Person</u>" shall mean any individual, whether a non-resident or a resident of the Rural Municipality of Rockwood or the Town of Teulon, and includes a corporation, firm, partnership, institution and association.
- d) "<u>Resident</u>" shall mean any individual who resides in or is the registered owner of real property either in the Rural Municipality of Rockwood or the Town of Teulon.

2. <u>SUPPLEMENTARY MUNICIPAL FUNDING:</u>

The cost of operating the Teulon-Rockwood Waste Disposal Grounds shall be supplemented by the fees and levies collected for the disposal of wastes from all users, including the Rural Municipality of Rockwood and the Town of Teulon. If, in a fiscal year, the amount of the fees and levies collected is insufficient to cover the operating costs of the Teulon-Rockwood Waste Disposal Grounds, the deficits shall be recovered equally by the Rural Municipality of Rockwood and the Town of Teulon.

3. CLASSES OF WASTE:

The following shall define, for the purposes of this By-Law, the classes of waste that may or may not be disposed of at the Teulon-Rockwood Waste Disposal Grounds:

- a) "<u>Agricultural Waste</u>" shall mean excess materials derived from agricultural activities and, without limiting the generality of the foregoing, shall include, but is not limited to, crop residues, herbicides, pesticides, fertilizers, and like materials from all agricultural pursuits.
- b) "<u>Animal Waste</u>" shall mean manure, excrement, animal carcasses, or any parts or mixtures thereof.
- c) "<u>Ashes</u>" shall mean the cold residue resulting from the burning of a substance.
- d) "<u>Combustible Waste</u>" shall mean, but is not limited to, tree boughs, stumps and branches, paper and cardboard products, wood and lumber and packaging materials derived from paper, cardboard and wood.
- e) "<u>Construction/Demolition Waste</u>" shall mean a mixture of waste building materials and rubble resulting from construction, remodelling, renovations, repairs, demolition or fire in buildings and other structures and includes, but is not limited to, lumber, plaster, concrete, drywall, glass, shingles, siding, electrical, and plumbing fixtures and piping or any combination thereof. Construction/Demolition Waste may be reclassified as Ashes, Combustible, Excavation, Metallic or Recyclable wastes provided said Construction/Demolition Waste is separated as per the Classifications defined in this Section.
- f) "Excavation Waste Clean Fill" shall mean natural soil, earth, sand, gravel, or any parts or mixtures thereof.
- g) "<u>Excavation Waste Rubble</u>" shall mean asphalt, concrete, stone and nonburnable building materials, or any parts or mixtures thereof.
- h) "<u>Hazardous Waste</u>" shall mean a substance that is designated a hazardous waste by regulation under The Dangerous Goods Handling and Transportation Act.
- i) "<u>Industrial Waste</u>" shall mean solid and liquid waste materials resulting from, or incidental to, the manufacture, processing, or like operation of factories, processing plants, industrial processes and manufacturing operations and includes waste such as putrescible waste from food processing plants and rendering plants and condemned foods and products.
- j) "<u>Landfill Waste</u>" shall mean all discarded waste but does not include Agricultural Waste, Animal Waste, Ashes, Combustible Waste, Hazardous Waste, Industrial Waste, Liquid Waste, Metallic Waste, Recyclable Waste, and Yard Waste.
- k) "<u>Liquid Waste</u>" shall mean sewage, sewage effluent, and sludge from septic tanks, holding tanks, and municipal sewage treatment systems.

- 1) "<u>Metallic Waste</u>" shall mean, but is not limited to, derelict vehicles, farm machinery, appliances, and any other items, goods or things that are comprised entirely or mostly of some type of a metal substance or substances.
- m) "<u>Ozone Depleting Substance</u>" shall mean substances as regulated under The Ozone Depletion Substances Act.
- n) "<u>Recyclable Waste</u>" shall mean those wastes as listed in Schedule "B" to this By-Law, as may be amended by the Board from time to time.
- o) "<u>Waste Oil</u>" shall mean oil, oil filters and oil containers.
- p) "<u>Waste Tire</u>" shall mean tires discarded for reasons of wear or damage.
- q) "<u>**Yard Waste**</u>" shall mean leaves, grass clippings, garden and flower bed vegetation and straw.

4. **<u>REGULATIONS:</u>**

All persons disposing of waste at the Teulon-Rockwood Waste Disposal Grounds shall do so in accordance with this By-Law and regulations contained herein or as established by Council from time to time.

- a) No person, other than the Caretaker as authorized, shall set or ignite any fire in the Teulon-Rockwood Waste Disposal Grounds.
- b) No person shall dispose of the following Classes of Waste at the Teulon-Rockwood Waste Disposal Grounds:
 - i) Agricultural Waste
 - ii) Animal Waste
 - iii) Industrial Waste
 - iv) Hazardous Waste
 - v) Liquid Waste
 - vi) Metallic Waste
 - vii) An Ozone Depleting Substance which has not been rendered safe as per the Ozone Depletion Substances Act
- c) The following Classes of Waste may be disposed of at the Teulon-Rockwood Waste Disposal Grounds:
 - i) Ashes, provided said ashes are cold
 - ii) Combustible Waste
 - iii) Construction/Demolition Waste
 - iv) Excavation Waste Clean Fill
 - v) Excavation Waste Rubble
 - vi) Landfill Waste
 - vii) Ozone Depleting Substance, provided the substance has been rendered safe as per The Ozone Depletion Substances Act
 - viii) Recyclable Waste
 - ix) Waste Tires
 - x) Yard Waste
 - xi) Waste Oil at the Oil Recovery Centre located at the Teulon-Rockwood Waste Disposal Grounds
- d) All persons who attend the Teulon-Rockwood Waste Disposal Grounds to dispose of waste shall separate their waste as per the Classes of Waste permitted for disposal at the Teulon-Rockwood Waste Disposal Grounds.

- e) All persons who attend the Teulon-Rockwood Waste Disposal Grounds shall report to the Caretaker's Office and shall pay the applicable fee(s).
- f) All persons who attend the Teulon-Rockwood Waste Disposal Grounds shall dispose of allowable waste in such designated area or bins, as the case may be, and in such a manner as directed by the Teulon-Rockwood Waste Disposal Grounds Personnel.
- g) No person shall at any time deposit or dump any waste outside of the fence of the Teulon-Rockwood Waste Disposal Grounds but shall only dispose of waste in those areas or bins, as the case may be, as designated by the Teulon-Rockwood Waste Disposal Grounds Personnel.
- h) It is unlawful for any person, other than the Caretaker as authorized, to salvage, pick over, scatter, search, or burn any waste in the Teulon-Rockwood Waste Disposal Grounds unless said person has received prior written authorization from the Teulon-Rockwood Waste Disposal Committee.
- i) No person shall loiter in the said Teulon-Rockwood Waste Disposal Grounds, but rather they shall simply attend the Teulon-Rockwood Waste Disposal Grounds for the purpose of disposing of allowable waste and thereafter they shall immediately leave the Teulon-Rockwood Waste Disposal Grounds.

5. **<u>FEES:</u>**

All persons who attend the Teulon-Rockwood Waste Disposal Grounds shall pay, at the time of attendance, the applicable fee for the disposal of the allowable waste as per the Class of Waste and the Fees as set out in Schedule "A" attached hereto and forming a part of this By-Law and as amended from time to time. All persons who pay the applicable fee shall receive a receipt from the Caretaker as set out in Schedule "C".

6. **PENALTIES:**

- a) Any person who contravenes or refuses, neglects, omits, or fails to obey or observe any provision of this By-Law is guilty of an offence and liable, upon summary conviction, in addition to costs, to a fine not exceeding FIVE HUNDRED DOLLARS (\$500.00) or to imprisonment for a term not exceeding one (1) month, or both such fine and imprisonment.
- b) Where the contravention, refusal, neglect, omission, or failure, including failure to comply with a notice, order or direction give by the Board, continues for more than one occurrence, the person is guilty of a separate offence for each occurrence.

7. **SEVERABILITY:**

If any provision of this By-Law is held to be invalid by any Court of competent jurisdiction, the remaining provisions of this By-Law shall not be invalidated.

8. **EFFECT:**

This By-Law, #19/09, shall come into full force and take effect October 1, 2009.

9. That By-Law #20/08 is hereby repealed.

SECTION II: ADDITIONAL FEES

Any person who contravenes or disobeys, or refuses or neglects to obey Section 4. d), e), f), or g) of the Regulations provision of By-Law #19/09 may be liable to a fee of \$100.00 for each contravention, refusal, neglect, omission, or failure, and such fee is in addition to the fee as setforth in Section I of Schedule "A" above.

SECTION III: EXEMPTIONS

Disposal fees shall not be charged to the Waste Collection Contractor for disposal in the Teulon-Rockwood Waste Disposal Grounds when he is disposing of curbside waste collections from the Townsites of Teulon, Balmoral and Gunton.
