BY-LAW #32/00

OF THE

RURAL MUNICIPALITY OF ROCKWOOD

Being a By-Law of the Rural Municipality of Rockwood for the purpose of regulating the operation and usage of the bulk-fill Community Wells located within the Rural Municipality of Rockwood.

WHEREAS Section 10 of Manitoba Regulation P210-331/88R under The Public Health Act identifies that the owner of a public water system at bulk loading facilities is responsible for the following:

- a) the operation and maintenance of the system; and
- b) to ensure adequate safeguards are in place to protect users of the system;

AND WHEREAS the following Community Wells are located in the Rural Municipality of Rockwood:

- a) Grosse Isle Community Well
 - Lot 1, Plan 27678, Pt. SW 6-13-1 EPM, Roll #5150;
- b) Balmoral Community Well
 - Lot 1, Plan 33413, Pt. NE 6-15-2E, Roll #222255;
- c) Gunton Community Well
 - Lots 1/3, Block 13, Plan 1263, SE 33-15-2E, Roll #260800
 - Gunton Greenwood Memorial Hall Inc.
- d) Komarno Community Well
 - Lots 3/6, Block 3, Plan 2071, Pt. NW 34-17-2E, Roll #382800; and
- e) Community Well at Parkdale Colony Holdings Inc. (Concord Colony Farms)
 - S ½ NW 16-13-3E, Roll #126800;

AND WHEREAS it is deemed expedient and in the best interest of the Municipality to pass a By-Law to provide for the safe usage and operation of the bulk-fill Community Wells located within the Rural Municipality of Rockwood;

NOW THEREFORE the Council of the Rural Municipality of Rockwood, in Council assembled, enacts as follows:

1. **DEFINITIONS:**

- a) "Community Wells" shall mean the community wells located at:
 - i) Grosse Isle Community Well (By-Law #26/91)
 - Lot 1, Plan 27678, Pt. SW 6-13-1 EPM, Roll #5150;
 - ii) Balmoral Community Well (By-Law #38/96)
 - Lot 1, Plan 33413, Pt. NE 6-15-2E, Roll #222255;
 - iii) Gunton Community Well
 - Lots 1/3, Block 13, Plan 1263, SE 33-15-2E, Roll #260800
 - Gunton Greenwood Memorial Hall Inc.
 - v) Komarno Community Well (By-Law #27/95)
 - Lots 3/6, Block 3, Plan 2071, Pt. NW 34-17-2E, Roll #382800; and

- vi) Community Well at Parkdale Colony Holdings Inc. (Concord Colony Farms) (By-Law #23/93)
 - S ½ NW 16-13-3E, Roll #126800;

2. **REGULATIONS:**

- a) All bulk-fill Community Well systems shall be properly locked and secured in order to prevent unauthorized use.
- b) Chemicals and/or pesticides shall not be permitted on the well sites.
- c) Tank flushing and/or chemical mixing shall not be permitted on the well sites.
- d) <u>Backflow Prevention:</u>

Any station supplied from a well must be protected from bacteriological or chemical cross-contamination by at least a full air gap or syphon break.

3. **PENALTIES:**

- a) Any person who contravenes or refuses, neglects, omits, or fails to obey or observe any provision of this By-Law is guilty of an offence and liable of a fine not exceeding \$1,000.00 and costs, and in default of paying, to imprisonment for a period not exceeding six (6) months.
- b) Each contravention shall be considered as a separate offence.
- 4. This By-Law shall come into force and effect on and from the date of its enactment.
